STREET OPENING MORATORIUM LIST

The City of Somerville's Street Opening Moratorium List will be in effect for a full 5 calendar years after the completion of street reconstruction. A list of streets covered by the moratorium can be found at the end of this document and will be updated annually.

The Engineering Division separates the Street Moratorium into three scopes:

- **Partial Pavement** which includes travel lanes only and excludes parking lanes;
- **Full Street** which includes the entire width (curb to curb) of the roadway, and
- **Complete Street** which includes the entire width of the roadway, and pedestrian and/or cyclist safety improvements.

In case a street needs to be disrupted and it is listed under the Street Moratorium, the Engineering Division requires the following restoration procedure:

Trench patches are not permitted on newly reconstructed streets. Instead, the contractor is responsible for providing mill & overlay from curb to curb, twelve (12) feet on each side of utility trench and repairing all pavement markings in-kind.

This can be reduced to just the travel lanes on partial pavement streets. On complete streets this may also include full width repaving of one or both separated bike lanes.
