The Commission Chair makes note that the alcohol license be severed from the other licenses, grant the application but may not be able to issue the license until the transaction is approved by the ABCC. Attorney Kemp requests a continuance on this matter pending the ABCC clarification. If the ABCC indicates licenses are required from both municipalities, the applicant is willing to do this.

The Commission Chair will request guidance from the ABCC. The Chair also has concerns for the Common Victualler and Entertainment Licenses and compliance issues, complaints and enforcement issues.

During that meeting, an accusation of a forged document was brought to the attention of the Board, by me regarding a Liquor License renewal. Upon review of the renewal document, I witnessed my initials and the date of inspection. It was a document that I did not sign and the date of inspection was not accurate because there was no inspection made at this establishment.

I, along with a Building Inspector, do an annual inspection of all establishments that serve alcohol for the purpose of renewal. Pepe Bocca was never inspected because of ongoing renovations. Several attempts were made during our inspection period to gain access, and none were successful. So the date of inspection was not accurate.

Upon investigating this document further, I found that my electronic signature was placed on the renewal form as it has been for the last several years. My signature now indicates my rank and initials. Prior to 2015 I signed each renewal document with my full name and rank.

These inspections are done annually, and then are signed off on the City of Somerville's Citizenserve by myself and the Building Inspector. Inspectional Services will then sign off on the renewal after confirmation from the City Clerk's office that a renewal application fee has been received.

Somewhere in that line, a miscommunication was made and the renewal permit issued. It is with respect that a formal apology be given to the Board, Mr Maione, and anyone in attendance on that date.

Chaille a member of the Police (arrived at 6:04pm) and Lt. MacLaughlan a member of the Fire Dept., applicants and members of the public. The meeting adjourned at 8:24pm

1. Minutes of April 8, 2019 Meeting

The Commission instructed the Secretary to include Lt. MacLaughlan's Letter of apology for Pepe Bocca in these minutes and to post them online. The Commission Approved these minutes

Communications

1a. Letter from Josiah Lee Auspitz to the Somerville Licensing Commission requesting procedural improvements, received May 16, 2019

Josiah Lee Auspitz appeared for this Communication. Mr. Auspitz states there is a discrepancy between the occupancy of this board and the occupancy certificate dated in 1972 for Pepe Bocca. He indicates that at the time of Pepe Bocca's application, another address was combined with this business. He states that the lower occupancy pertains to 414 Broadway only and in 1979 when John Sessa took over the premises, they merged

the next door premises. He indicates that the premises went from 1400sq. ft. to 2800 sq. ft. Mr. Auspitz states that he knows it is not this boards' problem, but wanted to bring it to the commissions' attention. Commission Lynch stated that was correct and we should discuss the 3 items in his communication. Mr. Auspitz has 3 suggested procedural recommendations 1. If a business is closed, due to illness, renovation or other causes, it should be standard procedure for the city inspector to leave a card with contact information, to arrange to enter the premises. 2. The clerk who issued the new and renewal certificate of inspection should prior to the renewal day have an updated list of businesses that inspections are incomplete so that certifications are not issued prematurely. Businesses on that list should be given due notice before the renewal date. 3. Lt. McLaughlan's Letter should be referenced in the minutes and made available. Commissioner Lynch stated, #3, Lt. McLaughlan's letter should appear in the April minutes, not the March minutes. #1, If a business closes, it is incumbent upon the license holder to notify the City Clerks Office. Pepe Bocca changed their hours of operation and did not notify the City. Their hours were erratic. This goes back to health issues and some issues the proprietor had with other departments. Inspectional Services stopped him from doing work that hadn't been permitted. Pertaining to #1, Commissioner Lynch will not speak for Inspectional Services, but stated we have 2 representatives from other departments as what their procedures are. Sgt. Chaille stated businesses are contacted by sending a letter, keep going back or make contact with a telephone number they have on file. Lt. McLaughlin stated Citizen Serve provides telephone numbers and emails for contact. He states he has left numerous cards on business doors and he is not contacted. He works with ISD for 304 Inspections for closed businesses prior to the expiration date of the certificate. Mr. Auspitz inquired as to the procedure employed for Pepe Bocca. Lt. McLaughlan replied that at least 2 possibly 3 attempts in November, knocking on the front door, leaving business cards for inspection prior to the end of the 2018 license. He received no call back and drove by many times during the day to see if there was any activity. There was none. It wasn't until the 1st of the year that he gained entrance through the back door. He stated this is authorized if a hazard exists. No permits were issued except for 1 that was ultimately cleared up. He brought the building inspector back in January or February when this started to transpire. Mr. Auspitz stated he did not hear of any correspondence from Lt. Maclaughlan. Lt. Maclaughlan replied he sent several emails without receiving a response. Commissioner Lynch stated one of the reasons he has been back before the commission many times is that each city department has had their own issues with his responsiveness. With trying to get him to be at the premises or to notify us that he is doing something on the premises. This goes back to July of 2018. Commissioner Lynch stated it's a matter of public record if Mr. Auspitz would like to request this documentation. Mr. Auspitz asked as part of #1, if these are already the procedures in place. Commissioner Lynch replied he cannot answer for other departments, he could ask Sgt. Chaille and Lt. MacLaughlan to represent their procedures, and feels Lt. Maclaughlan indicates email is the most expedient process. Commissioner Lynch stated the commission has a responsibility to ensure the safety of the public. Mr. Auspitz stated Commissioner Lynch assured him there was no improper communications between the landlord, his sister and Commissioner Lynch. He stated he is not sure that is the case city wide. Mr. Auspitz accepted the explanation. Commissioner Lynch stated Mr. Auspitz can send a public information request to show

him what transpired. Mr. Auspitz stated he would take Commissioner Lynch's word for this. Commissioner Lynch stated it was incumbent of this commission to help Giovanni understand the magnitude of what was happening. Things were out of his control and we did the best we could for 3- 4 months. For Mr. Auspitz 2nd point for the commission to look at, Commissioner Lynch indicated each department is responsible for their own licenses. The licensing commission can only answer for our responsibilities for Alcohol and Common Victualler Licenses. There is no central location for all the licenses. Somerville Licensing Commission requires all signatures prior to a license being issued. Commissioner Lynch stated he would bring it forward as an issue that was brought before the Licensing Commission. He also stated The Licensing Commission's role is to protect the public's health and safety to the licenses we issue. He stated several safety issues.

Mr. Auspitz questioned the occupancy again and a technical problem with the address. Lt. Maclaughlan stated it is the engineers who determine this. He stated he works with ISD and the Building Dept. and he will speak with them about the usable space and will bring this in to them tomorrow to request a floor plan for the licensee to provide with the useable space and the correct address. The engineers' office determines the address. Commissioner Lynch will bring it up in front of Proakis, ISD and administrative personnel in the Mayor's Office.

2a. Commissioner Allen to propose Marijuana Policies and Procedures including a discussion of the proposed rules. A vote will be taken on this proposal to implement the adoption of these Policies and Procedures

Chairman Lynch has requested Alex Melo of OHCD and MAC to appear on this matter. Commissioner Allen discussed setting hours of operation and believes that the state rules will be more active in enforcement than the commission most likely would be. He states he is happy to let the state's enforcement handle things he would have added. Going forward we can expand these rules. He indicated, Alex Melo has provided very firm language pertaining to ownership structure to ensure the person who owns the business, is the person controlling the establishment. Chairman Lynch had a question and states this matter is also in the Law Department hands as well. If an empowerment applicant is approved and the business closes, how does the city's legislation effect the balance of empowerment applicants and non-empowerment applicants, and has the CCC weighed in on this matter? Alex Melo stated that the CCC has not weighed in on this matter and it is a local issue as they see it. He believes the Licensing Commission would need to make a decision to pull one of the B Group licenses if this happens, or whether the City Ordinance should be updated to provide clarity. Commissioner McKenna questioned what if there are multiple violations of a licensee, and the penalty is a loss of licensure? The ordinance would not cover this issue. Alex Melo stated that he believes these are things that need to be looked at in the wording of the ordinance, and may require additional simple sentences to address this matter. Commission McKenna doesn't feel it would be fair to take away licensure from a business already approved due to the City Ordinance, through no fault of their own.

Chairman Lynch will request that the City Council address this through the legislation. Alex Melo stated he would be happy to work on this. Commissioner Allen suggested if this legislation is revised and amended, a discussion of simultaneously addressing multiple agenda items needing to be taken in a particular order or the order in which the commissions handles items having an impact on whether the items are approved or not.

Chairman Lynch asked Alex Melo to communicate to Mr. Proakis that the commission will be sending a request to him and this will also be sent to Councilor Ballantyne as this is the legislation side of the matter.

Alex Melo states the recommendations from the MAC may be in time for the October Licensing Commission Meeting

Commissioner Allen asked if the commission will receive the information provided to the mayor, for both recommended and not recommended applications. Alex Melo stated there will be a report that summarizes from the 1st round of MAC reviewed applications. The commission may only receive those that were offered the Host Agreement. All the applications are considered a public record, but they contain personal information that would need to be redacted if they were to be shared outside the MAC, both recommend and non-recommended applications. He would need to look at how this sensitive information should be handled. The Law Department would oversee what would need to be redacted.

Commissioner McKenna asked about #3 on the submission of 5.04 Additional Rules for Marijuana Establishments: Structural Change, and does this need to be voted on or is this an advisory? Chairman Lynch stated while these rules are under discussion, the language can be tightened up. A discussion followed about whether the Licensing Commission would need to approve Structural Changes. Procedures are in place to require various departments' approval. Commissioner McKenna feels that this item should be voided out. Chairman Lynch stated this requires more discussion. He asked if the CCC requires notification of structural changes. Alex wasn't sure, but would be surprised if they don't and that they are very strict. Chairman Lynch feels we need the answer to this question before striking it. He also stated we have additional questions to be sent in writing to Mr. Proakis, Alex Melo and the Law Dept.

This item has been continued

2b. Chairman Lynch to propose Late Fees for Special Alcohol Applications and Late License Renewals

Chairman is acceptable. A discussion followed as to how much the fees should be and the extra work late applications creates. The Commission has instructed the secretary to refer this matter to the City Clerk, the secretary and the Law Department for a suggested schedule of late fees.

This item has been continued for the October and/or November Meeting, to be instituted 1/1/2020

3. Mr. Grover Taylor has been notified to appear before the commission to discuss the closure of his restaurant Eat at Jumbo's Inc. d/b/a Sassafras located at 688 Broadway and his intentions with his license

Mr. Grover Taylor, 4 State St., Wilmington, MA appeared on this matter. He has been dealing with some personal issues. He discussed 2 options, the 1st option is to sell his lease to Advesa if the MAC approves the Recreational Marijuana license. The 2nd option would be to reopen his restaurant under a new d/b/a and menu, after the Ball Sq. Bridge reopens. He states he is current on all his permits, licenses, insurance and rent.

Chairman Lynch suggested the City Solicitor send an email to Mr. Taylor of the consequence of signing the Affidavit of zero hours (and that this does not take away his license). Mr. Taylor would need to come back to the commission to reinstate his hours of operation if he intends to reopen the restaurant.

Commissioner McKenna requests a copy of the email from the City Solicitor pertaining to this matter.

The commission instructed Mr. Taylor to provide an Affidavit to reduce his hours to zero. This signed document should be submitted within the month.

The commission has approved this request with the above document.

According to the criteria in Section 2.221 of the City Code of Ordinances, priority applicants were identified and based on a number of factors to insure they will best serve our community. The MAC recommended Category A priority applicants only. Category B applicants are Medical Marijuana Dispensaries in Somerville. At least half the licenses issued must be issued to Priority category A applicants. President Ballantyne respectfully submits these recommendations to the Licensing Commission for review.
