Boynton Yards Land Co. LLC proposes a Master Plan in the Boynton Yards subarea of the Master Plan Development overlay district, which requires a Master Plan Special Permit, for a 6.8 acre development site including a thoroughfare; multiple civic spaces totaling approx. 45,000 SF; and six buildings totaling approx. 1.365 million SF, including approx. 985,000 SF of commercial space, 340,000 SF residential space, 10% arts space, and 20,000 SF for a community center. Other addresses inclusive of this application are 34 Ward, 29 Harding, and 33 Earle Street.
