The quantities are estimates only and are not guaranteed. The City may opt to purchase additional or fewer quantities than those reflected in this bid package. The City has given the allowance of \$10,000.00 for the purchase of any additional items not listed in the list below.

If the City opts to purchase more than the estimated quantities in each category, the unit price for each item will determine the price of additional purchase.

The contract will be awarded within ninety (90) days after the bid opening. The time for award may be extended for up to 45 additional days by mutual agreement between the City and the apparent lowest responsive and responsible bidder.
