**Item #4** – Request that parking is restricted at the following locations for the duration of the School Street bridge closure between May 15, 2020 and April 30, 2021:

- a) West side of School St between Richdale Ave and Highland Ave (approximately 18 permit parking spaces)
- b) East side of School St between Richdale Ave and Montrose St (approximately 4 permit parking spaces)
- c) North side of Pearl St between Medford St and Walnut St (approximately 16 permit parking spaces and 8 two-hour except by permit parking spaces)
- d) East side of Sycamore St between Richdale Ave and Montrose St (approximately 4 permit parking spaces)
- e) West side of Walnut St between Highland Ave and Medford St. The loading zone, 3 two-hour except by permit spaces, and 1 permit parking space that are currently there will be moved to the eastern side of the street.

**Item #5** – Request that the full length of Montrose St is converted from one-way to two-way vehicular traffic for the duration of the School Street bridge closure between May 15, 2020 and April 30, 2021

**Item #6** – Request that School St between Highland Av and Medford St is converted from one-way to two-way for construction vehicles only for the duration of the School Street bridge closure between May 15, 2020 and April 30, 2021.

**Item #7** – Request that Walnut St between Medford St and Highland Ave is converted from one-way to two-way for emergency vehicles only for the duration of the School Street bridge closure between May 15, 2020 and April 30, 2021.

**Item #8** – Request that contraflow bicycling is permitted on Sycamore St between Richdale Ave and Montrose St for the duration of the School Street bridge closure between May 15, 2020 and April 30, 2021.

**Item #9** – Request that the “No Parking Here to Corner” designation on the east side of Lowell St, just south of Albion St, is extended by an additional 40 feet to improve sight lines for vehicles and

pedestrians approaching from Albion St. This would restrict on-street parking at 2 spaces that are currently designated as residential permit parking.
