DECISION DATE: March 25, 2020

This decision summarizes the findings made by the Zoning Board of Appeals regarding the time extension application submitted for 1 McGrath Highway. The application was submitted on January 28, 2020 and deemed complete on March 19, 2020. The first public hearing was held on March 25, 2020. On March 25, 2020 the Zoning Board voted to approve the extensions. This decision was filed with the City Clerk on April 6, 2020.

SUMMARY OF PROPOSAL

Somerbridge Hotel, LLC requested an extension to their Variances previously granted on March 6, 2019. Variances have one year to be acted upon, but a six-month extension can be requested. If a 6-month extension were granted, the Variances would expire September 6, 2020.

RECORD OF PROCEEDINGS

On March 25, 2020 the ZBA held a public hearing. Present and sitting at the public hearing were Members Orsola Susan Fontano, Danielle Evans, Elaine Severino, Josh Safdie, Anne Brockelman, and Drew Kane.

Following public testimony and consideration of the statutory requirements to approve or deny an extension of previously granted variances, Danielle Evans moved to approve the 6-month extensions. Elaine Severino seconded. The Board voted 6 to 0 and the motion passed.


Findings:

- The Board finds that the application was submitted to the Board prior to the variances expiring.
- The Board finds that the applicant was diligent in pursuing a building permit and project financing but has had to overcome environmental remediation of the site.

Any appeal of this decision must be filed within twenty days after the date this notice is filed in the Office of the City Clerk, and must be filed in accordance with M.G.L. c. 40A, sec. 17 and SZO sec. 15.5.3.

In accordance with M.G.L. c. 40 A, sec. 11, no variance shall take effect until a copy of the decision bearing the certification of the City Clerk that twenty days have elapsed after the decision has been filed in the Office of the City Clerk and no appeal has been filed, or that if such appeal has been filed, that it has been dismissed or denied, is recorded in the Middlesex County Registry of Deeds and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title.

Also in accordance with M.G.L. c. 40 A, sec. 11, a special permit shall not take effect until a copy of the decision bearing the certification of the City Clerk that twenty days have elapsed after the decision has been filed in the Office of the City Clerk and either that no appeal has been filed or the appeal has been filed within such time, is recorded in the Middlesex County Registry of Deeds and indexed in the grantor index under the name of the owner of record or is recorded and noted on the owner's certificate of title. The person exercising rights under a duly appealed Special Permit does so at risk that a court will reverse the permit and that any construction performed under the permit may be ordered undone.

The owner or applicant shall pay the fee for recording or registering. Furthermore, a permit from the Division of Inspectional Services shall be required in order to proceed with any project favorably decided upon by this decision, and upon request, the Applicant shall present evidence to the Building Official that this decision is properly recorded.
