

# COVID-19 Health & Safety Plan and Layout Museum & Indoor Historical Sites

The public has an expectation and a right to be safe while visiting Museum & Indoor Historical businesses. The businesses have a responsibility to ensure their attendees the safest environment practicable and to adopt a Health & Safety Plan (HASP) to address the current COVID 19 pandemic and to guard against the spread of the virus. This HASP must be submitted to the City of Somerville before opening.

**To be approved by the City of Somerville Inspectional Services Department to open an indoor recreation facility, you must:**

1. Complete a State COVID-19 Control Plan
2. Complete this COVID-19 Health & Safety Plan (HASP) and Layout
3. Submit both documents by email to the City of Somerville Inspectional Services Department at [isd@somervillema.gov](mailto:isd@somervillema.gov)
4. Receive confirmation that your HASP and Layout was approved by the Inspectional Services Department

This HASP details how the Commonwealth reopening guidelines will be applied to your specific business. **Keep the printed HASP and Layout on hand in your facility.**
