**Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.**

HUD recaptured funds from the program because of a difficult rental market in the Somerville community. The real average rents in the area fluctuate between \$200 and \$500 a month above the FMR for studio and one-bedroom apartments, making it hard or impossible to lease units within the CoC geography.

In July 2018, Heading Home was awarded a grant from the City of Somerville Affordable Housing Trust Fund that will go a long way toward bridging the gap between FMR and real market rents. Heading Home expects to be able to fully expend the CoC grant funds if awarded.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Somerville Better Homes 3 is a permanent supported housing program providing units for 13 chronically homeless individuals. The 13 units are scattered site apartments that house participants from the Somerville community.

Our program uses a Housing First approach. Residents do not have to be sober or accept services to access or retain housing. While participation in supporting services is not mandatory, most residents choose to engage with their assigned case managers and identify self-sufficiency goals for their service plans. All our program units are in neighborhoods that are close to public transportation, commercial centers, and bus routes. Additionally, healthcare and service providers tend to be within walking distance or are easily accessible by public transit.

If clients decide to engage in services, the case management meetings address financial management, access to mainstream benefits, support for mental health and substance abuse counseling and recovery, employment and educational needs, tenancy skills, and other relevant services. Heading Home also provides move-in assistance, start-up furniture, and assistance with utility transition for new residents as needed.
