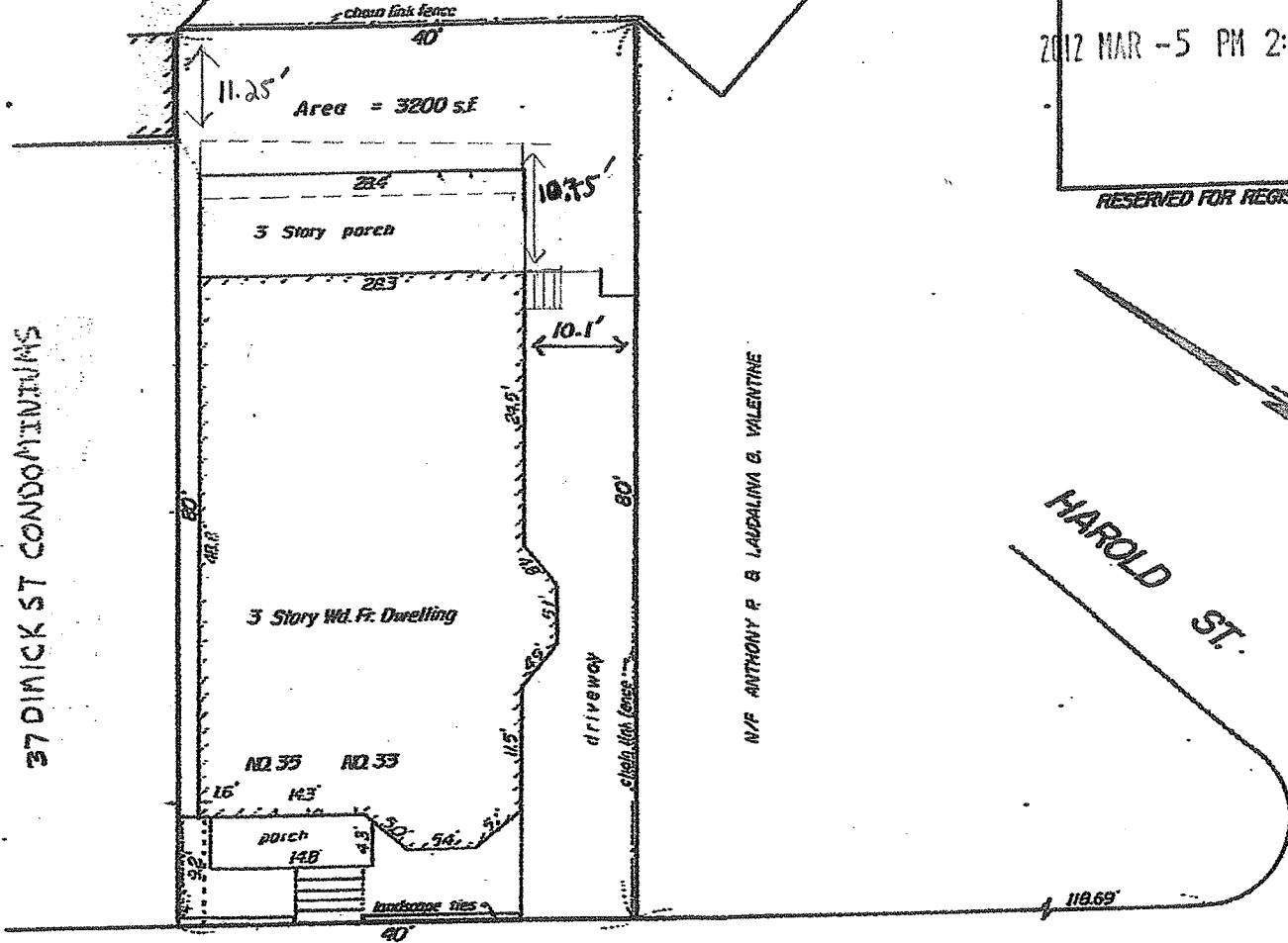

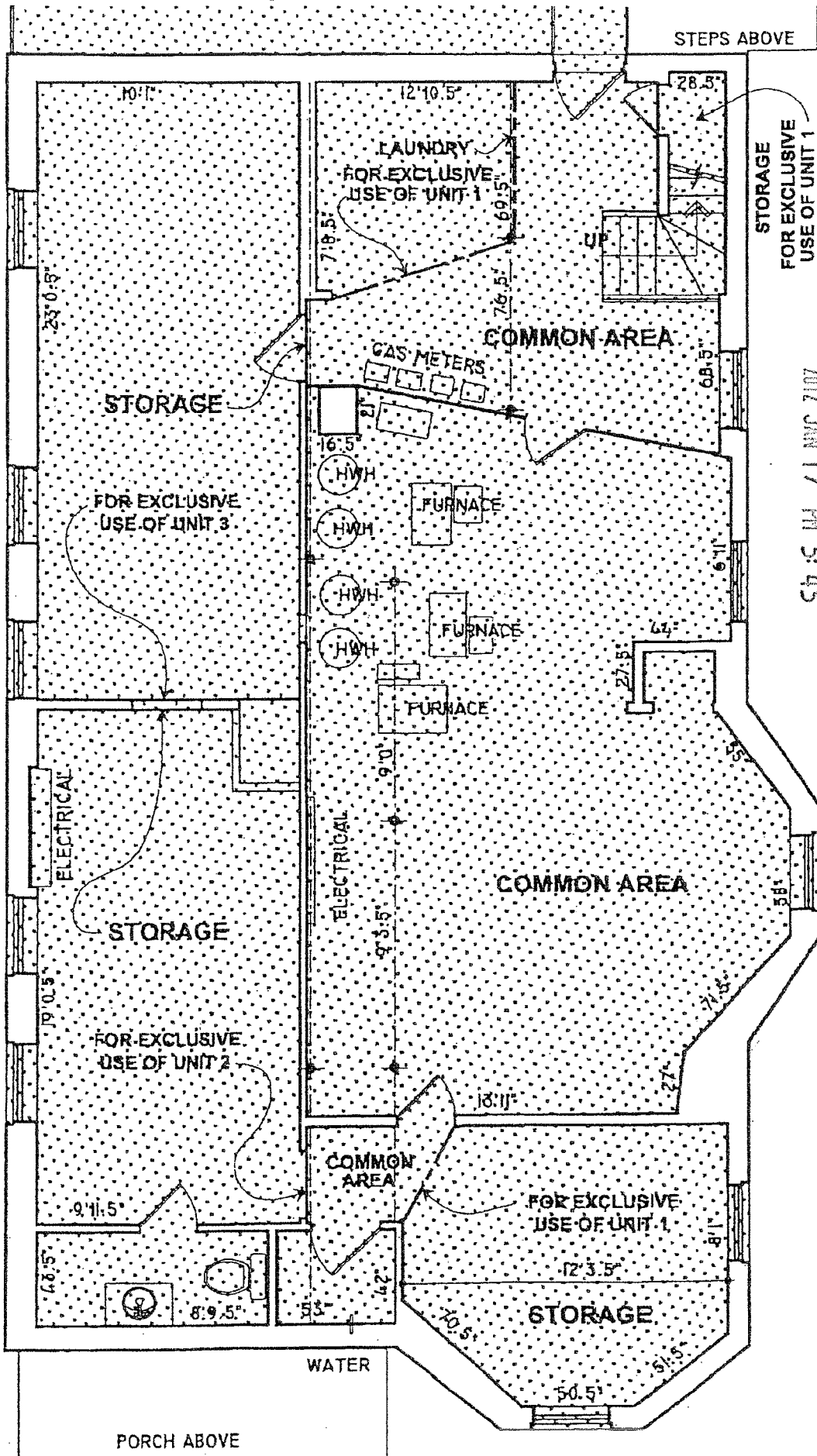

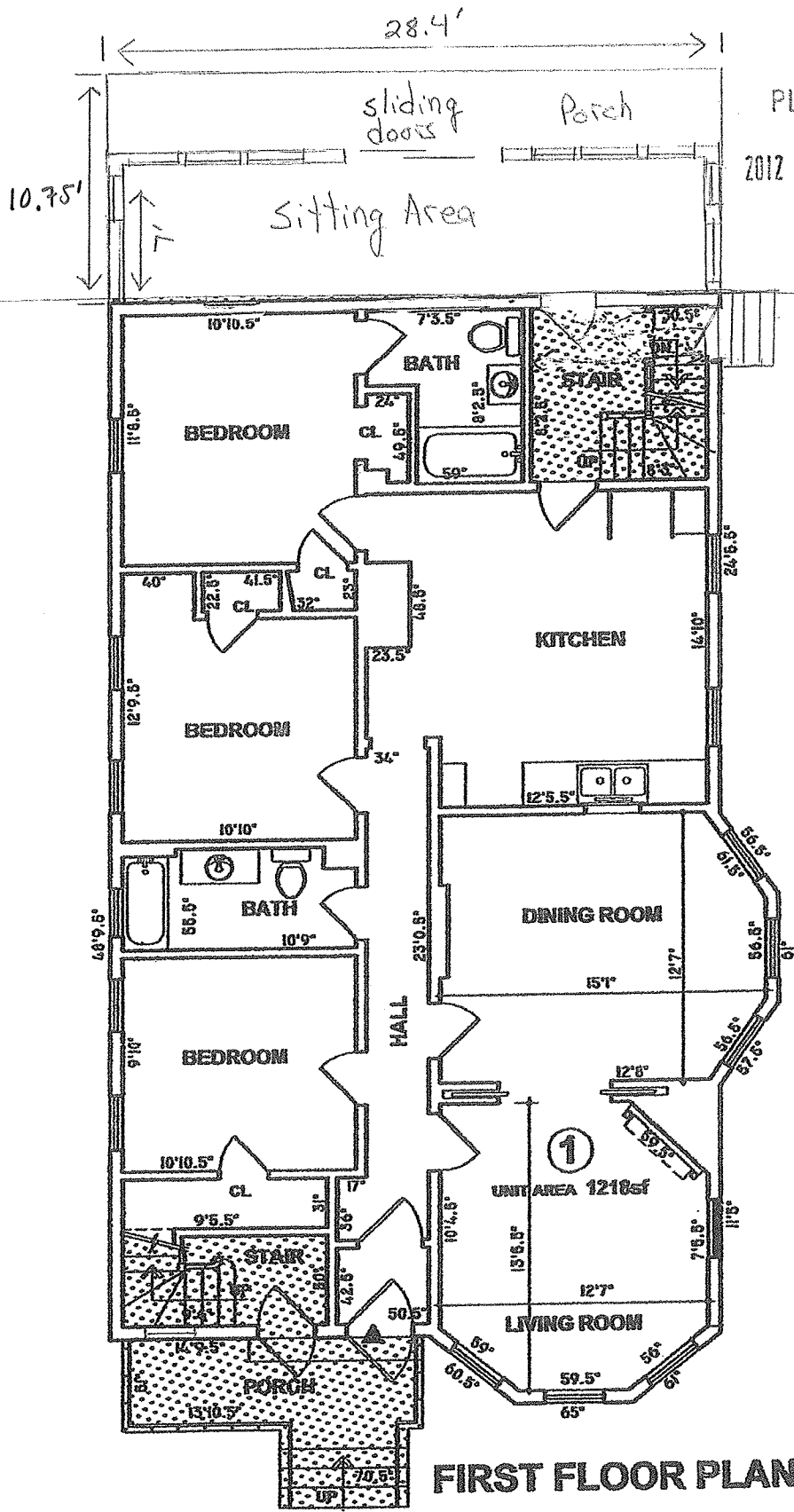

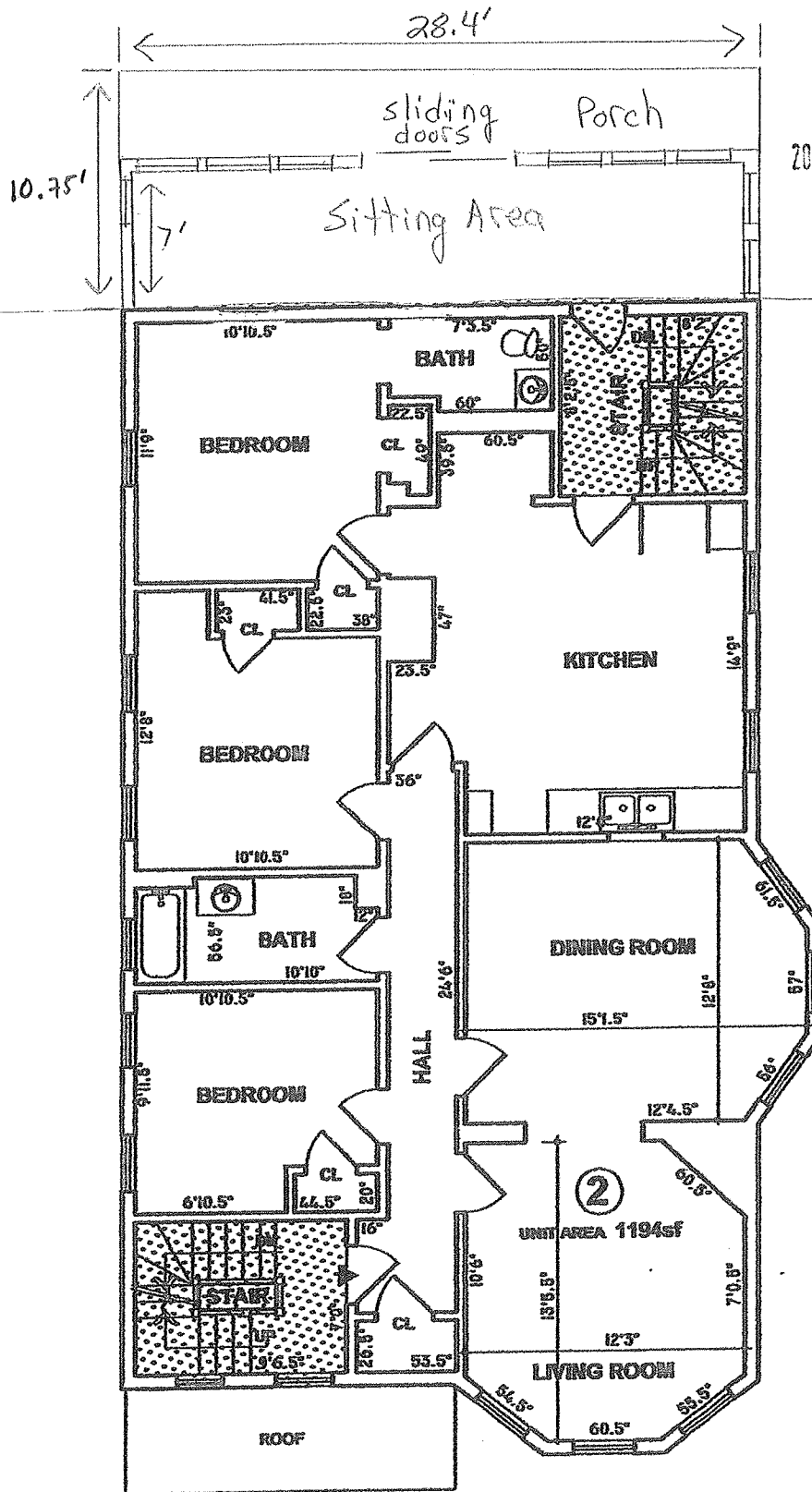

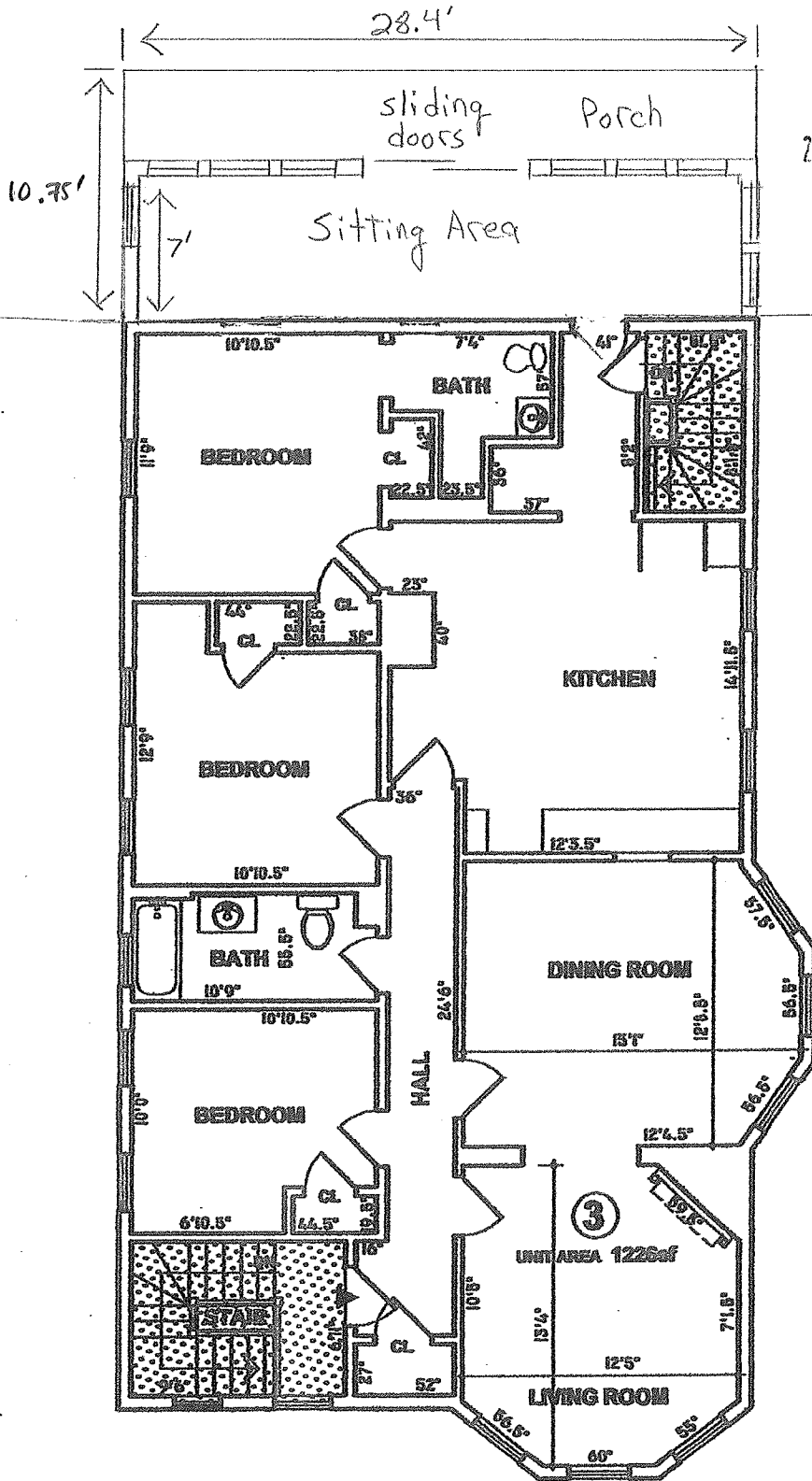


SECOND FLOOR PLAN

THIRD FLOOR PLAN

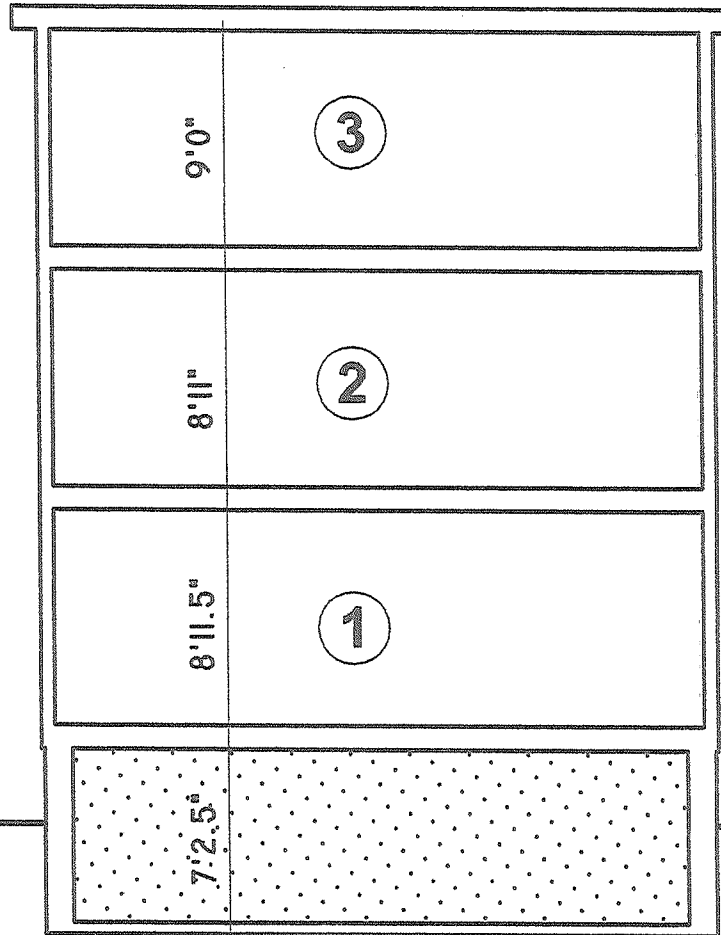

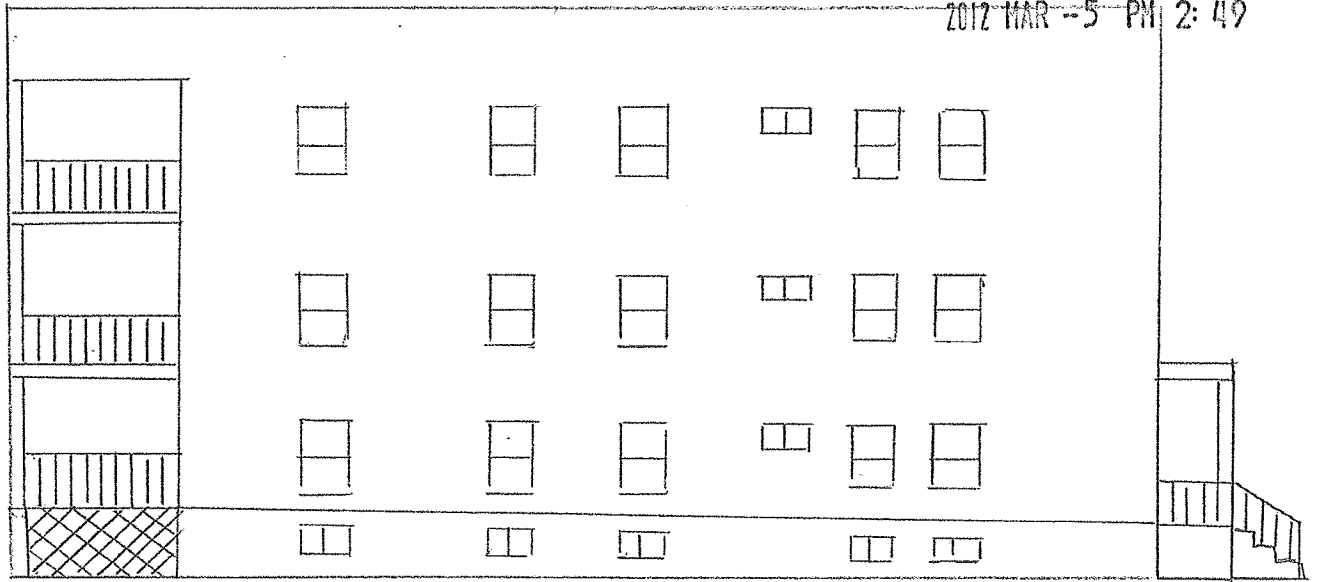

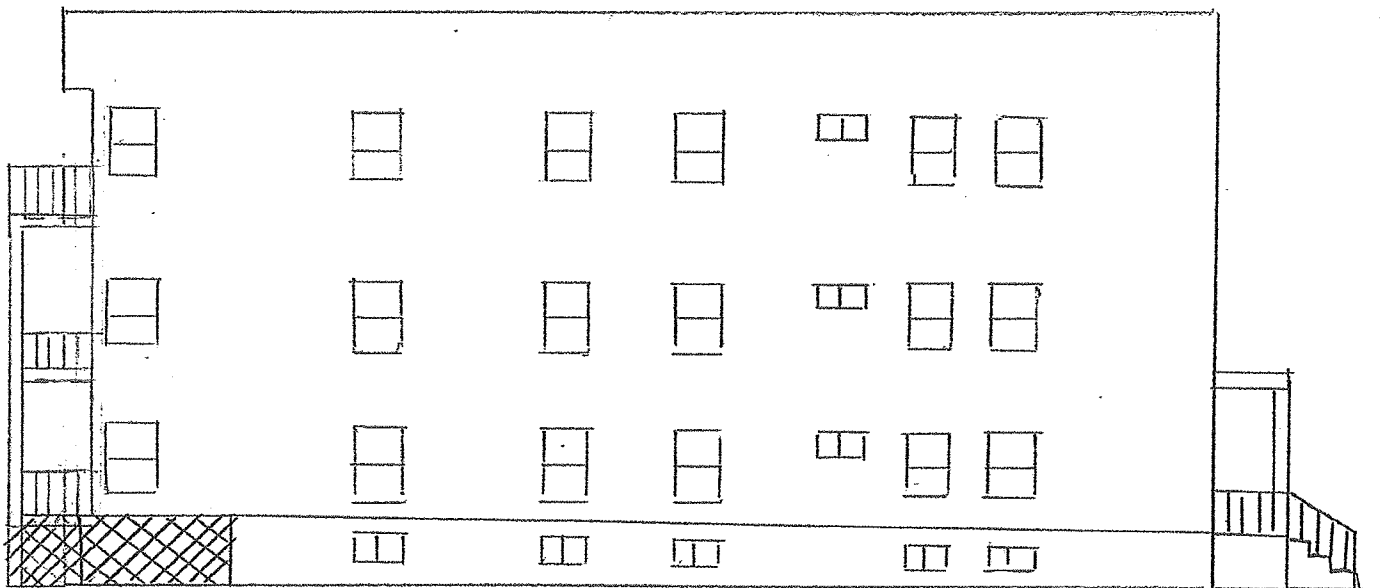

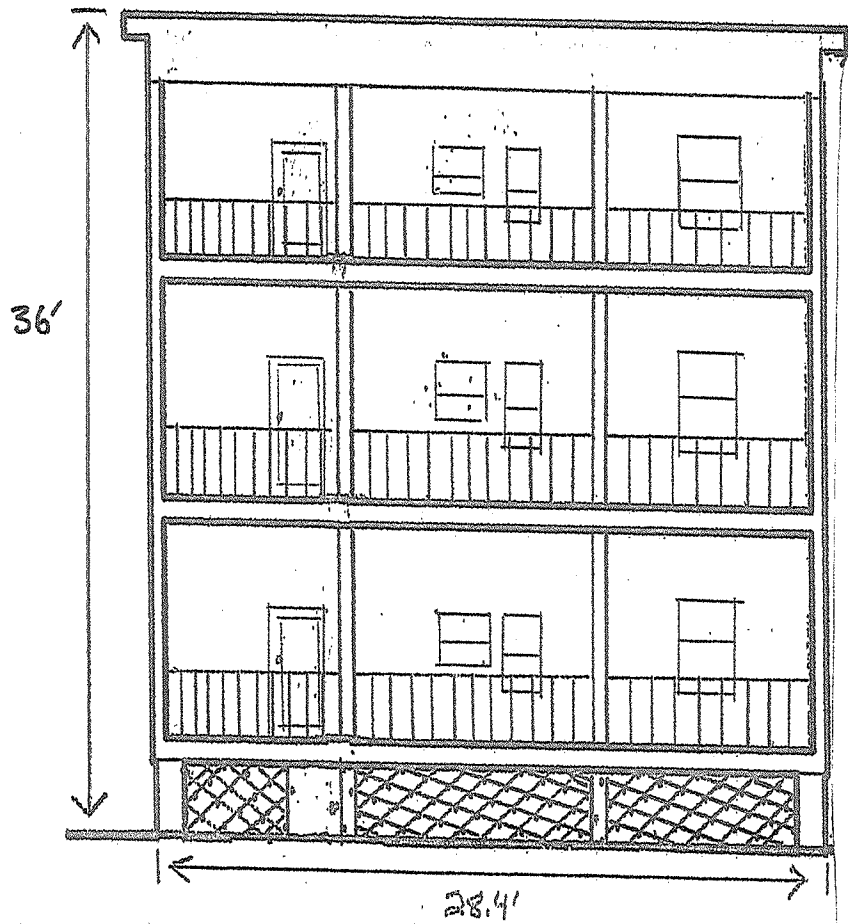


Rear View

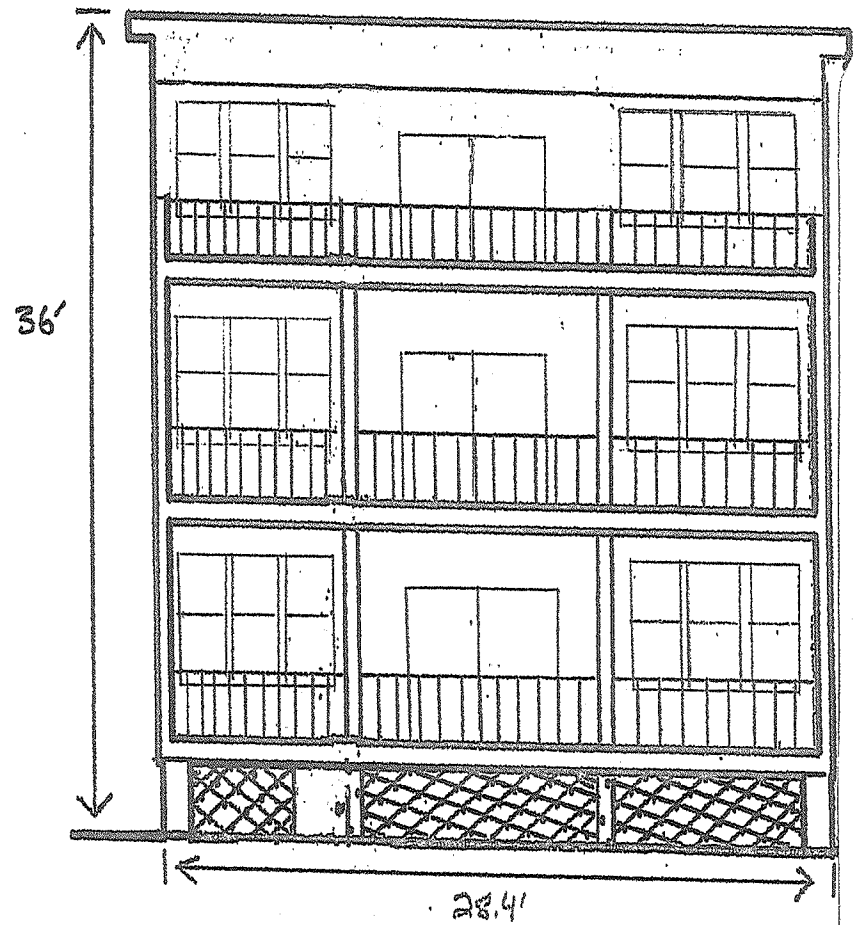

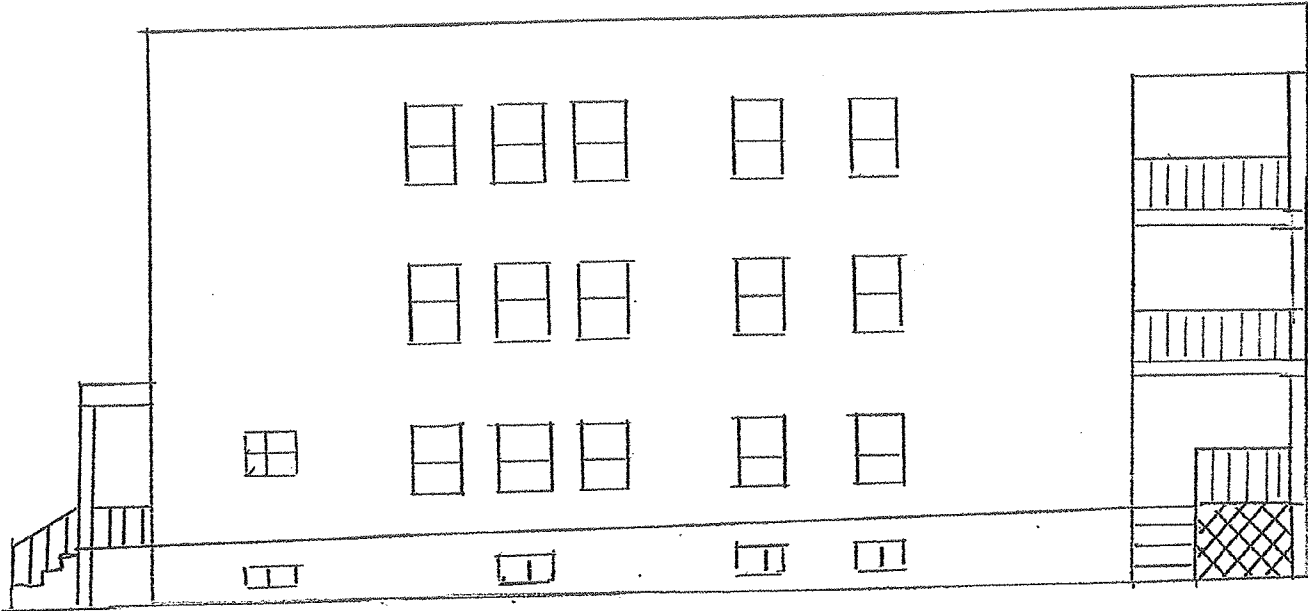


Right Side View
