### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The Shelter Plus Care (S+C) program provides rental assistance and tenancy stabilization services to formerly homeless individuals and families with disabilities. At capacity, there are a total of 8 units and 13 beds. The Somerville Homeless Coalition (SHC) utilizes rental assistance dollars for participants to rent units and a supportive housing case manager provides comprehensive, low barrier, community and home-based supports. The program embodies a housing-first approach. It promotes goals and outcomes related to helping participants achieve and maintain residential stability; increasing and maintaining skills, income and mainstream benefits; and, promoting greater self-sufficiency through participant engagement in community services that help them achieve their goals. Upon turnover units are targeted to chronically homeless households.

To help participants maintain residential stability, SHC assists them in finding housing accessible to services and which fit their needs. We have a variety of amenities such as grocery chains, pharmacies, convenient stores, and an array of other services in the area. Somerville has many human service agencies, an extensive transit system, vocational and educational programs, daycare centers, health treatment options and other opportunities.

Participants have many needs beyond housing placement alone to insure long-term viability of housing tenancy. Our work and our philosophy as an agency is to connect our clients to mainstream supports to help them reintegrate into the community and stabilize in their housing so they do not return to the homeless system. We help them address their service needs through the many partnerships we have with other service agencies. Clients are provided with opportunities to maintain or increase their skills and income by applying for entitlement benefits, engaging in employment, vocational rehabilitation, volunteerism, educational enhancement, financial literacy and other life skills development activities.

Our individualized support services focus on helping clients develop the psychosocial coping skills and knowledge necessary to help them make decisions that positively affect their lives. This array of services are designed and tailored to help foster greater self-determination.

Our community's need is great. There is a severe shortage of affordable housing and an extremely low vacancy rate within our region, which are substantial barriers to helping us move our homeless clients into housing. The Somerville-Arlington CoC 2018 Point-In-Time count identified 134 homeless people on a given night. Our community needs Continuum of Care Program support to help all of our homeless men, women and children navigate the fragmented service system and overcome the array of obstacles to securing and maintaining housing that is permanent, safe and affordable.
