Shortstop is a transitional housing program that provides housing and transitional care to 9 homeless young adults, ages 18-24, from the Somerville area. Over the course of a year the program expects to serve 16 - 18 young adults. The young adults can stay in the program up to 24 months, but many will be able to achieve their goals in a shorter period of time. ShortStop offers a variety of services including educational and vocational support services for young people transitioning to adulthood. Shortstop assists each young adult to make a successful transition to stable permanent living situations by promoting independent living skills in a supportive environment. The goals of the program are to have at least 87% of the young adults move into permanent housing by discharge, for 87% to be working and increasing their income, and for 50% to be in school in order to improve their ability to maintain gainful, sustaining employment. ShortStop coordinates its efforts with other participating agencies in the Somerville CoC. In addition, the program collaborates with state partners as necessary, schools, colleges, mental health and substance abuse counseling centers, legal services and other needed service providers.
